

To whom it may concern:

This letter is to serve as a request that the appeal not be granted for development application DA 117-24 due to the following.

- Windiana Farms Ltd. Has farmland located near this proposed potato storage facility and has apprehensions about its proximity to our irrigation pump site and field which we believe could cause undue hinderance to our access.
- We believe the range road is too narrow to have tractor trailers departing from the proposed facility. We believe there could be challenges when we are moving agricultural equipment, that trucks turning in and out could cause a disruption of traffic flow in both directions.
- We would also like to express concern that the proposed facility would obstruct the view of the railroad tracks. There are homesteads along the range road as well as our employees travel it quite frequently, considering recent events with an accident occurring on those tracks we do not believe the storage facility should be placed in close proximity to them, perhaps another site could be considered as we are not opposed to a storage facility just the location.

We appreciate you taking these concerns into consideration in your decision.
